The District Health Office, Islamabad, intends to pre-qualify workshops, authorized dealerships, and vendors registered with the Sales Tax and Income Tax Departments. Applicants must be listed as Active Taxpayers (ATL) with the Federal Board of Revenue (FBR) and must have their own offices, spare parts inventory, skilled manpower, well-equipped workshop, and requisite expertise based in Islamabad.

This pre-qualification process is being undertaken for repair and maintenance services required during the Financial Year 2025–26, in accordance with Rule 15, read with Rule 42(a) and (b) of the Public Procurement Rules, 2004, as amended from time to time.

3. Eligible applicants include workshops, original manufacturers, authorized dealers, and vendors registered with the Income Tax and Sales Tax Departments, listed on the Active Taxpayers List (ATL) of the Federal Board of Revenue (FBR), and duly registered on E-PADS of PPRA.
4. The applications for pre-qualification must reach the District Health Office, Islamabad, no later than 10:30 AM on October 17, 2025. Late submissions will not be entertained.
5. The applications will be opened publicly on the same day, i.e., October 17, 2025, at 11:30 AM in the Committee Room of the District Health Office, Islamabad, by the Committee in the presence of applicants' representatives who may wish to attend.
